


Aircraft Movements

The percentage change for aircraft movements in April 2020 was incorrectly reported as -136.7 during last month's COW report. The correct percentage change for April 2020 is -15.5.





Medevac Flights 2020

Regulatory Compliance:

• The Airport Manager has received confirmation of the acceptance of the Interim AE (Accountable Executive) and is currently waiting on approval of the Airport Operations Manual. The Airport Wildlife Management Plan and Winter Maintenance Plan are currently being updated to ensure compliance to Transport Canada regulations.

Other Information:

- All special events at the airport have been put off or on hold until the COVID-19 pandemic is over.
- The airport restaurant "The Hungry Hangar" is now open from Wednesday to Sunday for takeout only.
- Expected decrease in fuel sales and movements for the months of June due to COVID-19.
- The operations staff worked to remove and trim trees violating the Obstacle Limitation Surface (OLS) in the vicinity of the airport. The operations staff have begun summer maintenance such as grass cutting and tree trimming
- Updating of emergency call out numbers for emergency response checklists
- New standard operating practices in place (working in the vicinity of the runway, Notam procedures, and Vehicle inspections.)

• Av gas and Jet Fuel are at sufficient levels

COVID Information:

- All Flight schools have been temporarily shut down
- FLY GTA flight service has been indefinitely postponed
- Access to the terminal has been restricted to staff and two essential tenants
- Passenger traffic down across the province
- COPA & FOTA meetings and other gatherings have been suspended
- Fuel available on site with card-lock systems, through fuel supplies, and through callout services
- Messaging changed on website and all social media accounts
- Emails sent to staff detailing:
 - Cleaning procedures for COVID-19
 - Hand washing techniques Provided World Health Organization documentation/infographic
 - When to use masks Provided World Health Organization documentation/infographic
- Hand sanitization stations at all entrances to buildings
- Numerous directions on how and why to wash hands provided to staff and contractors onsite
- Disinfectant spray available for commonly touched surfaces (steering wheels, radio mics, etc.)
- 2m Separation while working (jobsites and tasks)
- Can be reduced if PPE and safety direction is provided
- One person per vehicle at a time. If an exception is to be made; Employees are to notify management in advance. Maximum of two people per vehicle. Employees must agree to proceed with or without PPE (non-medical masks and gloves will be available for each vehicle).
- High touch surfaces in trucks are regularly cleaned
- Dispose of soiled cleaning clothes, disinfection cloths, disposable gloves and any other items in contact with respiratory tract secretions in a waste disposal bag.
- Posted signs encouraging good respiratory hygiene, hand hygiene, and other healthy practices.

COVID-19 Measures implemented since May 20th

• Social distance markings within the terminal to promote social distancing.

- The airport has ordered sneeze guard to protect clients and staff from the impacts of COVID-19
- The Airport has also received guards for the POS (Point Of Sale) terminals that are changed after each customer uses said terminal.
