### RE: Permitted Use Changes at West Rocks and Pottawatomi Conservation Areas

At the July 24, 2024 Grey Sauble Conservation Authority Board of Directors Meeting the following motion (#FA-24-059) was passed:

"WHEREAS, under Section 21(I) of the Conservation Authorities Act, GSCA may use lands that are owned or controlled by the authority for purposes, not inconsistent with its objects, as it considers proper;

AND WHEREAS, GSCA maintains a Permitted Uses Guideline that identifies existing permitted uses (Table 1) and will guide future decisions regarding updating, revising, or implementing new permitted uses as endorsed by the Board of Directors on March 27, 2019;

That, the GSCA Board of Directors endorse revising the permitted uses at the West Rocks and Pottawatomi Conservation Areas by removing hunting as a permitted use and clarifying compliance with Municipal by-laws where hunting is permitted."

Subject: Change to Permitted Uses – Pottawatomi & West Rocks

#### **Recommendation:**

WHEREAS, under Section 21(I) of the Conservation Authorities Act, GSCA may use lands that are owned or controlled by the authority for purposes, not inconsistent with its objects, as it considers proper:

AND WHEREAS, GSCA maintains a Permitted Uses Guideline that identifies existing permitted uses (Table 1) and will guide future decisions regarding updating, revising, or implementing new permitted uses as endorsed by the Board of Directors on March 27, 2019;

That, the GSCA Board of Directors endorse revising the permitted uses at the West Rocks and Pottawatomi Conservation Areas by removing hunting as a permitted use and clarifying compliance with Municipal by-laws where hunting is permitted.

### **Strategic Initiative:**

This item is related to the "Enhance GSCA Land Management" priority set out in GSCA's Strategic Plan.

### **Background:**

In reviewing the Permitted Uses Map generated by GSCA for public use and identification of property location, classification, and permitted uses, staff considered the category of property (management area, conservation area, nature preserve), proximity to urban uses, intensity of use, and permitted uses.

In undertaking this review, two properties stuck out as having the hunting use potentially incompatible with their primary purpose or surrounding uses: West Rocks and Pottawatomi/Jones Falls.

### **Analysis:**

None of the mandatory programs or services required by the Conservation Authorities Act include hunting.

Under O.Reg. 688/21: Rules of Conduct in Conservation Areas section 5 (in summary) no person shall kill, trap or pursue a wild bird, reptile, or animal or possess, shoot, discharge or use a gun, firearm, slingshot or archery equipment except under a permit issued by an authority.

GSCA has addressed this regulation by maintaining a list of permitted uses on properties under Table 1 of the Permitted Uses Guideline. Table 1 indicates which GSCA properties permit hunting in accordance with Provincial and Federal regulations. Specific to Spirit Rock, no hunting is permitted within 500m of the Corran Ruins. Specific to Pottawatomi, only archery hunting is permitted. There is no specified restriction for the West Rocks area. No additional written permission from GSCA is currently required for hunting. Trapping is dealt with differently under the guideline. Even where identified as potentially permitted, trapping requires explicit written permission and license agreement from GSCA; no change is proposed by this report to trapping.

Report 07-2019 presented with the guidelines to the Board on March 27, 2019 anticipated that permitted uses on GSCA properties might change either as a result of GSCA revisiting the uses or a request from a user group or both. Changes to permitted uses generally require the endorsement of the Board by way of Resolution (exceptions to Board approval apply for short term uses such as events or research).

The following is an analysis of West Rocks and Pottawatomi individually as their reasons for being reconsidered differ.

#### 1. West Rocks

- a. West Rocks is a Conservation Area highlighted in the GSCA Explore Guide.
- b. Currently permits hunting in accordance with Federal and Provincial regulations.
- c. West Rocks Conservation Area is entirely within the City of Owen Sound
- d. City of Owen Sound By-law 1995-119 prohibits (in summary) the discharge of guns or other firearms, crossbows, and long-bows in the City of Owen Sound. There are some exceptions (such as Peace Officer use) but none that would address hunting at the West Rocks.

Changing the permitted uses formally in GSCA policy will simply align with the Owen Sound By-law and reduce chance of misinterpretation.

Any of our member municipalities have the authority to pass by-laws under the Municipal Act to regulate discharge of weapons (Section 119) and this could occur without our knowledge. Therefore, staff also recommend a change to Table 1 of the Permitted Uses Guideline to indicate that Municipal By-laws be added as a consideration for hunting in addition to "Provincial and Federal regulations". This would cover any additional instances like West Rocks. While municipal by-laws would apply whether or not GSCA lists them, it would remind visitors to check with local municipalities before making plans for hunting.

#### 2. Pottawatomi

- a. Pottawatomi is a Conservation Area highlighted in the GSCA Explore Guide (map excerpt below).
- b. The Niagara Escarpment Plan classifies this location as Natural Environment and indicates uses to include Bruce Trail and picnicking, fishing, hiking and cross-country skiing.
- c. Trail counter data indicates over 10,000 visitors from the Jones Falls/OSTC footbridge location alone in each of 2022, 2023. As the site has three other public access locations this does not account for all visitors.
- d. Hunting was last known to have been considered for this site by the Board in 1990 at which time hunting permissions were reduced to archery only.
- e. Currently archery is the only permitted form of hunting
- f. In 1997 the Grey Sauble Conservation Foundation initiated the Memorial Forest Program. Pottawatomi is one of the three existing memorial forest locations.
- g. In addition to the residential use east of the site, the surrounding area has also continued to be developed with urban type mixed uses along Highway 6&21 as well as Thom Drive with parking lots and contractors yards adjacent to GSCA property.




Figure 1: Map of Jones Falls & Pottawatomi from the Explore Guide 2021

It is recommended that no hunting be permitted at Pottawatomi Conservation Area.

The Vision of GSCA is a healthy watershed environment in balance with the needs of society.

GSCA considers the needs of society in permitting hunting at a number of properties. Fifty-three properties were identified by Table 1 of the Permitted Uses Guidelines in 2019. We now know that hunting is already not permitted at West Rocks by municipal by-law.

The recommendations herein are to ensure alignment with municipal by-laws regarding hunting and remove archery hunting from Pottawatomi Conservation Area.

Specific actions staff will undertake to enact the recommendations include:

- 1. Revise Table 1 of the Permitted Uses Guideline to:
  - a. Remove "Hunting" as a permitted use from the West Rocks and Pottawatomi Conservation Areas, and;
  - b. To the Permitted Uses Note No. 8 which reads "Where permitted, hunting must be in accordance with Provincial and Federal regulations" add at the end "and Municipal by-laws", and;
  - c. Remove "\* Archery hunting only" from the Permitted Uses Notes for Pottawatomi;
- 2. Update any other GSCA information and materials to reflect the changes above as outlined by the Communication Strategy below.

### **Financial/Budget Implications:**

This report and the resolution of the Board of Directors will be shared with the City of Owen Sound and Municipality of Georgian Bluffs Council and Clerks for information.
