8. Business Items

i. Orientation

a. Forestry

Forestry Coordinator, Mike Fry, provided a presentation on GSCA Forestry Operations. Mr. Fry gave an overview of the department's tree sale and planting programs.

A Member asked with regard to agricultural land being planted with trees rather than maintaining the agricultural land, and if there are conversations with the landowner around why. Mr. Fry responded that staff do have those conversations and try to ascertain the landowner's motivation for the planting project. It was noted that staff need to balance that with meeting budgeted revenue targets and the landowner's choice for their property.

A Member asked with regard to the inclusion of a non-native species of Norway spruce. Mr. Fry responded that the species in question has been classed as a naturalized species and is not considered invasive and does not outcompete other native species.

A Member asked if the landowners are required to maintain the planted land in perpetuity or is there a time commitment. Mr. Fry responded that the landowner makes a 15-year commitment with Forest Ontario to not intentionally harm the planted trees.

A Member asked what staffing contingent is required to plant trees, i.e. planting 200,000 trees 10 years ago versus the 41,000 being planted in the present. Mr. Fry responded that in the past, there

were two planter tractors and two teams of staff. With the reduced number of trees being planted in the present, staffing has been reduced significantly.

ii. Operations

a. Fleet Truck Purchase

Operations Manager, Morgan Barrie, spoke to the need to continue updating GSCA's fleet. Staff circulated a tender for a compact truck to twenty-five dealerships and received nine bids. The tender allowed for gas, hybrid, or electric options.

Staff recommended moving forward with the bid from Peninsula Ford for two Ford Maverick AWD compact trucks. This bid also included a full set of winter tires for each truck.

A Member asked if staff have any towing requirements now or in the future that would present an issue with the smaller truck. Mr. Barrie responded that with the towing package on the noted trucks there is a 4,000 lb towing capacity which meets the needs of the operations department. Additionally, GSCA has other larger trucks should the need arise.

A Member asked how the overage between what had been set aside in 2023 would be covered. CAO, Tim Lanthier, responded that the funds were planned to be drawn from the fleet reserve in 2023 and that the amount being withdrawn from the reserve will be extended to cover the full cost of the vehicles.

iii. Administration

a. Prosecution Agreement

CAO, Tim Lanthier spoke with respect to the pilot project agreement between GSCA and Grey County to provide support in the way of prosecution services for Section 28 and Section 29 offences.

It was noted that GSCA did not utilize Grey County's prosecution services for Section 29 offences within the last year. However, there is an offence under Section 28 that is currently being handled.

Staff recommended entering into a longer-term agreement with Grey County.

A Member asked for the clarification on what geographic areas these services would cover. Mr. Lanthier responded that the agreement covers matters within the GSCA watershed in both Bruce and

Grey Counties. Additionally, it was noted that the Saugeen Valley Conservation Authority is also party to the agreement.

b. New Budget Expenditure

CAO, Tim Lanthier spoke to a request made that would see GSCA sponsor the Land Between Water book project through the pre-purchase of 20 copies of the book, at a discounted rate. The project is being spearheaded by photographer and author, Mark Zelinski, and will feature the Niagara Escarpment.

Staff request approval to withdraw up to \$1,200 dollars from the Administration Reserve to cover the cost of the purchase/sponsorship. These copies would be retained and used for gifts of recognition.

There was discussion around the use of public funds and the selection criteria used in sponsoring these types of projects and requests.

CAO, Tim Lanthier noted that GSCA would not be donating funds but rather purchasing the books and that includes the purchase also includes recognition of GSCA as a sponsor in the project.

iv. Water Management

a. Town of the Blue Mountains Water Quality Delegation Update

CAO, Tim Lanthier, provided an update on communications between GSCA and the delegate who spoke to the Board in March, regarding water quality concerns in the Town of the Blue Mountains.

A Member asked if GSCA staff have received any communication from the Town of the Blue Mountains since the May Board meeting to request assistance or discussion the issues presented in the delegation. Mr. Lanthier responded that staff have not heard from the Town of the Blue Mountains on this matter.

A Member asked with regard to the Town of the Blue Mountain's official plan. Mr. Lanthier responded that setbacks are considered in two ways, Natural Hazards and Natural Heritage. It was noted that due to the recent changes to the Conservation Authorities Act, GSCA is restricted from providing comments on Natural Heritage items and can only comment of items of a Natural Hazard nature.

vii. Conservation Lands

a. Hunting at Pottawatomi and West Rock Properties

CAO, Tim Lanthier, spoke to the provided report and staff's recommendation for changing permitted uses at the Pottawatomi and West Rocks properties.

Staff recommended removing hunting from the list of permitted uses for both of these properties.

It was noted that both properties are very popular with hikers. West Rocks is particularly popular with students from nearby schools. Additionally, West Rocks falls within the boundaries of the City of Owen Sound, which has a by-law that does not allow hunting within city limits.

WHEREAS, under Section 21(I) of the Conservation Authorities Act, GSCA may use lands that are owned or controlled by the authority for purposes, not inconsistent with its objects, as it considers proper;

AND WHEREAS, GSCA maintains a Permitted Uses Guideline that identifies existing permitted uses (Table 1) and will guide future decisions regarding updating, revising, or implementing new permitted uses as endorsed by the Board of Directors on March 27, 2019;

That, the GSCA Board of Directors endorse revising the permitted uses at the West Rocks and Pottawatomi Conservation Areas by removing hunting as a permitted use and clarifying compliance with Municipal by-laws where hunting is permitted.

b. Update to Grey County By-Law Management Agreement

CAO, Tim Lanthier, spoke to GSCA's Grey County Forest Management and Forestry By-Law Agreements and the need to amend the agreements. It was noted that the current agreement had been renewed in 2019. However, it places restrictions on GSCA's business practices, namely GSCA's ability to mark woodlots within Grey County on a fee for service basis. Mr. Lanthier added that GSCA's forestry staff provide this service in Bruce County and has previously provided this service in Grey County.

It was stressed that forestry has been an integral part of GSCA's business model since it's inception and that not being permitted to mark trees in Grey County reduces revenue generation work in planting, tree sales, and MFTIPs.

There was general support expressed for the proposed changes to the agreement.

10. CAO's Report

The CAO, Tim Lanthier, gave a brief report on activities from June and July.

GSCA staff are working with several community groups in the Eugenia area to revitalize the cenotaph at the Eugenia Falls Conservation Area. The project will include redoing the gardens with native plants, installing natural stone urns and benches, and repainting the fencing. GSCA received a \$3,000 grant from Community Foundation Grey Bruce at assist with funding the project and other fundraising and volunteer efforts will facilitate funding the remainder of the project.

GSCA has completed construction on three new parking areas at Massie Hills, Griersville Memorial Forest, and Wodehouse to support access to trails in the areas. Funding for the Massie Hills lot was provided by Grey County and the Bruce Trail Conservancy (BTC), while the funding for the Griersville

and Wodehouse lots were provided entirely by the BTC. The BTC has created a new side trail that connect the Griersville Memorial Forest site with the main trail.

The Grey Sauble Conservation Foundation received a \$2,000 bequest from the estate of Elwood Moore. This was presented to the GSC Foundation on May 23rd by Elwood's son, Brian Moore.

Additionally, the GSC Foundation held its annual Memorial Forest Commemorative event on June 24th at the Inglis Falls Arboretum. It was a well attended and well received event.

Chair Robert Uhrig and Mr. Lanthier attended the CO quarterly council meeting on June 24th. There was nothing to report.

Mr. Lanthier and the GSCA Chair and Vice-Chair met with the executive members of the GSC Foundation Board on July 2nd. There was great discussion and several action items resulted.

On July 11th, Mr. Lanthier gave a presentation on GSCA's strategic plan to the SON Joint Council at the Chippawa's of Saugeen Band Office.

Mr. Lanthier presented to the Silver C's organization on July 23rd.

Work on GSCA's strategic plan continues, with the consultation period nearly completed. Staff are collating the collected data and conducting gap analysis. A meeting with Board members will be scheduled to discuss directions and actions.

Lastly, Mr. Lanthier informed the Board that there is to be a Source Protection Committee meeting on July 26th.
