Schedule 'A'

Six Specific types of Open-Air Burns

This Schedule with key notes will help to determine the type and size of your Open-Air Burn based on the required setbacks of your property.

Definitions:

"Material to burn" - clean and clear wood or by products of clean and clear wood.


"Approved Device" means a device/container that is approved in this bylaw or that is designed to contain an open-air-fire and

is listed as an approved device by a recognized national or international testing/certification organization, or as approved by the Chief Fire Official as being suitable to contain an Open-Air Fire.


"Combustibles" are materials that can combust (burn) in air. Types of Combustibles include, but are not limited to, any building or structure, tree, hedge, long grass, fence, roadway, overhead wires, or other combustible materials.

Permit required - no inspection required automatic approval after permit is completed online (permit holder does not have to call prior to each burn)

Key notes - Outdoor fireplace

- An approved device is a manufactured non-combustible enclosed container such as fire bowls with spark arrestors on top or chimineas that is not greater than 0.8m(2.6ft) in diameter and not higher than 0.8m (2.6ft).
- Fire cannot burn between the hours of 1:00 a.m.to sunrise of the same day, except if property is over 1 acre of land.
- Only one burning fire permitted at one time per property.
- Only permitted to burn clean clear wood or by products of clean clear wood.
- Combustibles not permitted within a 1.5m (5ft.) from the surrounding edge of the approved device in all directions.
- Flames are not to be not wider than the approved device and not higher than 0.8m (2.6ft) above the approved device.
- A portable ABC Fire Extinguisher of not less than 2 1/2lbs or water to be readily available at all times while fire is burning.
- Fire to be maintained with a constant watch and control over the fire from the time of the setting of the fire until the fire is completely extinguished.
 - a) Fire Device not greater than 0.8m (2.6ft.) in diameter
- b) Setback area no combustibles within 1.5m (5ft.) surrounding the edge of the approved fire device

Key notes - Fire pit


- An approved device enclosed on all sides and constructed of masonry, concrete, stone, heavy gauge metal or other non-combustible materials that is not greater than 1.0m (3.2ft) in diameter.
- Fire cannot burn between the hours of 1:00 a.m.to sunrise of the same day, except if property is over 1 acre of land.
- Only one burning fire permitted at one time per property.
- Combustibles are not permitted within 3m (10ft.) from the surrounding edge of the approved device in all directions.
- Flames shall not exceed 1.0 cubic meter.
- A portable ABC Fire Extinguisher of not less than 5lbs or water to be readily available at all times while fire is burning.
- Fire to be maintained with a constant watch and control over the fire from the time of the setting until the fire is totally extinguished.
- A) Fire Device not greater than 1.0m (3.2ft.) in diameter
- b) Setback area no combustibles within 3m (10ft.) surrounding the edge of the approved fire device


Six Specific types of Open-Air Burns

Permit required – review and/or inspection required before permit issued (permit holder shall notify prior to each burn)



Key notes - Demolition fire

• An approved (with review and/or inspection) Open Air Fire that has been granted a Permit by the Chief Fire Official.

- Property to be greater than 1 acre of land.
- To contact and advise of each time of an active burn.
- Only one burning fire permitted at one time per property.
- Combustibles are not to be within a 6m (20ft) radius from the edge of the Brush Fire in all directions.
- Materials to be added to Bonfire can be within 3m (10ft) of the Bonfire and the pile cannot be higher than 2.2m (7.2ft).
- Permit holder shall be within 6m(20ft) of the burn site at all times and shall have a portable ABC fire extinguisher of not less than 10 lbs or an adequate means of water and/or equipment to extinguish fire promptly while the burn is being conducted.
- a) Fire not greater than 2.2m (7.2ft) in length, by 2.2m (7.2ft)) in width, 2.2m (7.2ft) in height.
- Setback area Combustibles not to be within a 6m (20ft) radius from the edge **b)** of the Bond Fire in all directions

Key notes - Brush fire

- An approved (with review and/or inspection) open air fire of brush to be burned for the sole purpose of burning wood, tree limbs and branches.
- The pile of brush cannot exceed 3m (10ft) in length, by 3m (10ft) in width, by 3m (10ft) in height.
- Combustibles are not permitted within 6m (20ft) from the edge of the burn in all directions.
- To contact and advise each time of an active burn.
- Only one burning fire permitted at one time per property.
- No person shall set, maintain or operate a Brush Fire earlier than sunrise or later than two hours prior to sunset.
- Materials to stoke or add to the fire shall not be closer than 3m(10ft) and not higher than 3m (10ft) of the burn.
- Permit holder/agent to be on site within 6m(20ft) with adequate equipment and/or water to extinguish the fire promptly while the fire is burning.
- Fire not greater than 3m (10ft) in length, by 3m (10ft) in width, by 3m (10ft) in height
- Setback area Combustibles are not permitted within 6m (20ft) surrounding **b**) the edge of the approved burn in all directions

Key notes - Controlled fire

- An approved (with review and/or inspection) Open Air Fire that has been granted a Permit by the Chief Fire Official.
- The pile of materials cannot exceed 6m (20ft) in length, by 6m (20ft) in width, by 6m (20ft) in height.
- Property of the Controlled Fire to be zoned as Agricultural (A), Special Agricultural (SA) or Rural (R) by the Municipality Zoning By-law in force and effect at the time of permit application, and is in use for Farming.
- Combustibles are not permitted within 15m (50ft) from the edge of the burn in all directions.
- Only one burning fire permitted at one time per property.
- A Controlled Fire shall not be set, maintained or operated earlier than sunrise or later than two hours prior to sunset.
- Permit holder/agent to be on site within 15m(50ft) with adequate equipment and/or water to extinguish the fire promptly while the fire is burning.
- Fire not greater than 6m (20ft) in length, by 6m (20ft) in width, by 6m (20ft) in height
- Setback area Combustibles are not permitted within 15m (50ft) surroundingb) the edge of the approved burn in all directions

Demolition Fire requires an open building permit to demolish and approval from the Chief Fire Official, contact Inter Township Fire Department for process.
