### Recommendation

That Committee of the Whole accept report FIN2021-07 regarding 2020 Council Remuneration and Expenses, for information purposes.

### Background

As per Section 284 of the *Municipal Act, 2001*:

“The Treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement on remuneration and expenses paid in the previous year to,

- (a) Each member of council in respect of his or her services as a member of the council or any other body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- (b) Each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and
- (c) Each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.”

## Analysis

By-law 2018-086 was passed September 19, 2018 to establish amounts payable to members of Council for their services.

In 2020, remuneration to members of Council was as follows:
