Water emergencies are prevalent and will continue to be so in greater numbers with the increase in population and tourism in the area.</p> <p>The size of the site would require significant initial investments along with ongoing maintenance to address the eroding shoreline if the north area were to become a swimming area. The site would need to be separated for obvious safety reasons and the space simply does not exist at this site. A swimming hole would then create the need for change rooms and restrooms facilities similar to those at Centennial Park and Sarawak Family Park.</p> <p>This is also a site for bulk water pick up by a few providers and farmers who are essential to our food supply; where would they go to service the agricultural sector in the area. The focus needs to be placed on the community that lives here and the needs placed before the "wants". This water access provides an invaluable resource for emergencies and also provides access to freshwater for the neighbouring farms. This should take priority over recreational uses.
