

# The Corporation of the Township of Georgian Bluffs

## By-law Number 2020-134

Being a By-law to appoint members of Council and the public to various Committees and Local Boards.

Whereas Section 5 (3) of the *Municipal Act*, S.O. 2001, c.25, as amended requires that a municipal power shall be exercised by by-law; and

Whereas Section 8 (1) of the *Municipal Act*, S.O. 2001, c.25, as amended provides municipalities broad authority to govern its affairs as appropriate to enhance the municipality's ability to respond to municipal issues; and

Whereas Committee and Local Board appointments were formerly established for a term of two years, expiring on December 31, 2020; and


Whereas Council of the Township of Georgian Bluffs hereby deems it necessary and expedient to appoint members of Council and the public to various standing committees, local boards, and other committees; and

Now Therefore, the Council of the Corporation of the Township of Georgian Bluffs enacts the following:

1. That the Committee and Local Board appointments listed in Schedule A, attached hereto and forming part of this by-law, are hereby confirmed.
2. That all appointments, as reflected in Schedule A, shall be recognized and in effect on January 1, 2021 and shall remain as such throughout the remainder of the current Council term.
3. That By-law 2018-104 is hereby repealed.
4. That this By-law shall come into force and effect upon passing thereof.
