At their meeting on September 13, 2021, Council of the Township of Georgian Bluffs declared the Wiarton Keppel International Airport to be surplus to the needs of the municipality, and deemed the property for sale.

Per the Township's Disposition of Land policy, a by-law to authorize the sale will be presented for enactment at the October 6, 2021 meeting of Council. The public are welcome to attend the meeting, ask questions regarding the sale or submit written comments for consideration of Council. The meeting will also be livestreamed to the Township of Georgian Bluffs YouTube channel.

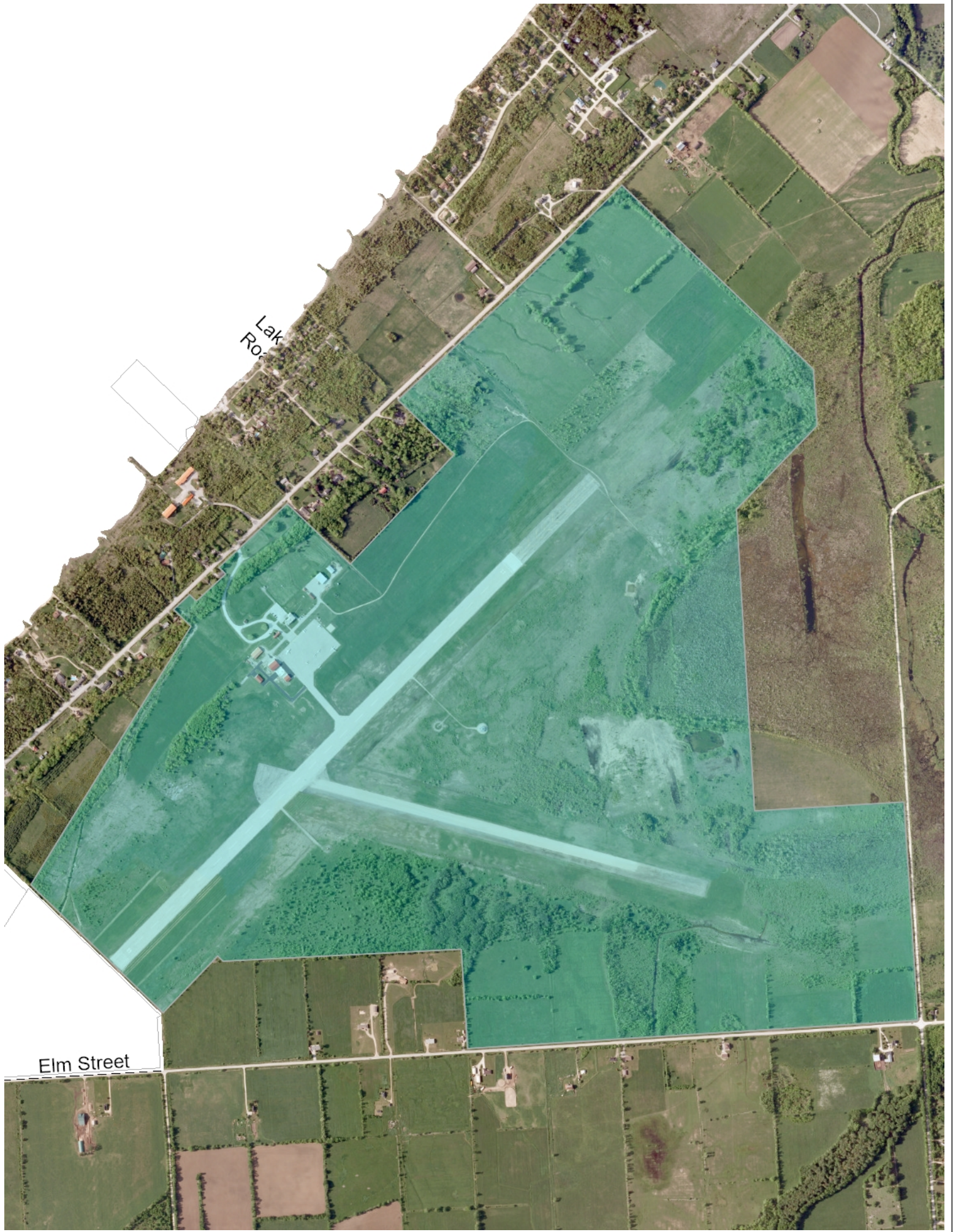

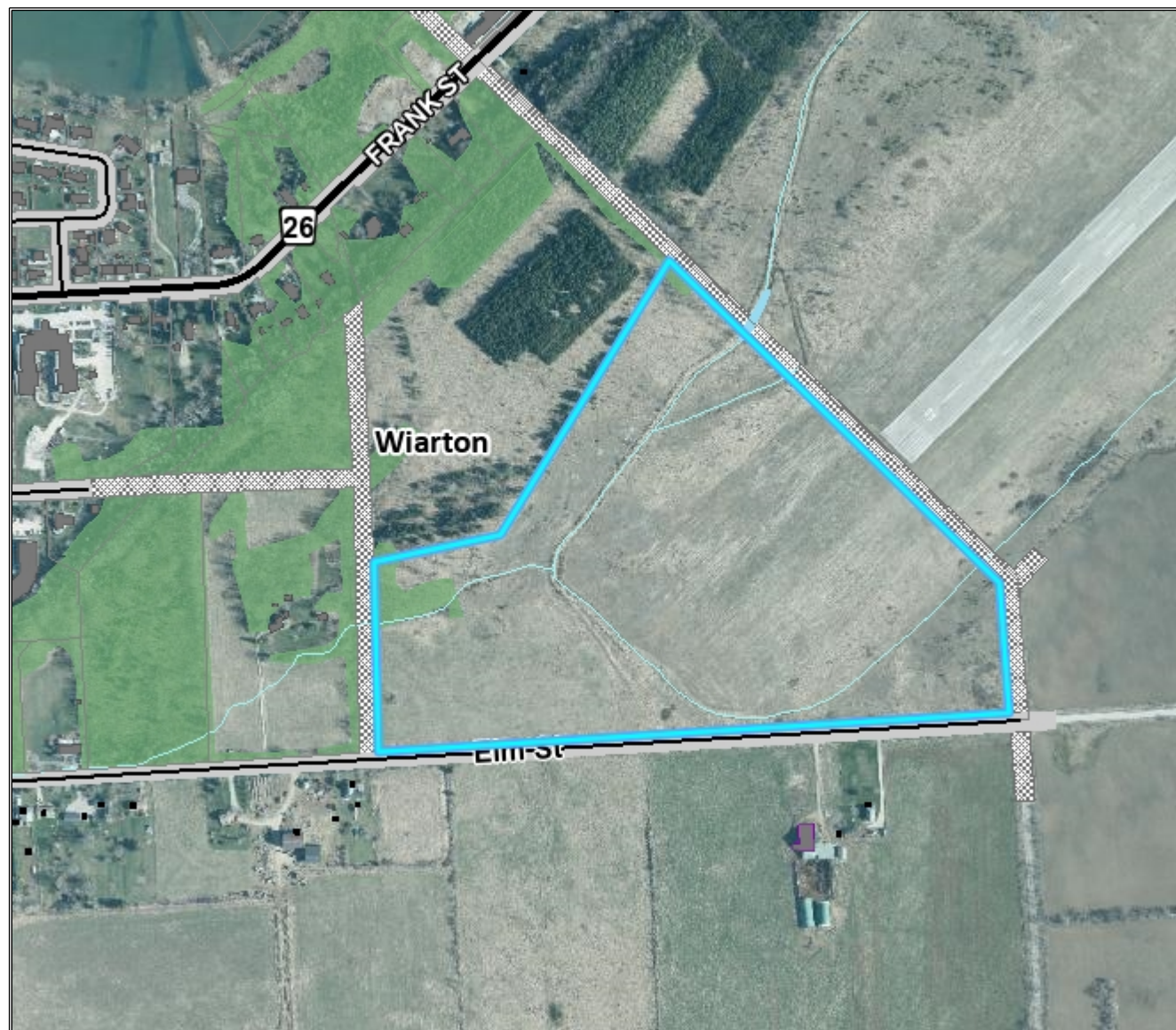
