The requirement is that the work is done before any disturbance (e.g. building), but SON is not usually consulted at the building permit phase.

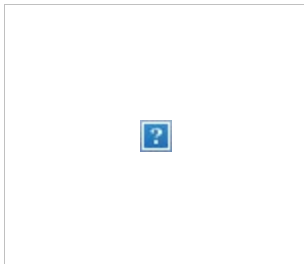
Ultimately if the goal down the road is to build, it would be wise to do the assessment at this stage so the landholders know what they are getting into. SON will need to be involved at the Stage 2 assessment (which is likely triggered here by Ministry standards, not SONs).

Hi Jenn,

I see. Subdivision aside, this area has extremely high archeological potential (19th century Ojibway settlement and proximity to water etc.). The severance itself is just a line on a map, but it implies future disturbance. If any disturbance is contemplated for this site SON will require that an archeological assessment is done prior. SON will need to be notified when the arch assessment is initiated.

Please let the proponent know, and make sure relevant Municipal and Ontario Ministry staff are aware of this requirement.
