## By-law Number 2022-012

Being a By-law to the imposition and collection of Water Rates for water systems owned and operated by the Township of Georgian Bluffs.

Whereas Section 5(3) of the *Municipal Act*, S.O. 2001, c.25, as amended requires that a municipal power shall be exercised by by-law; and

Whereas Section 11(3) of the *Municipal Act*, S.O. 2001, c.25, as amended provides that municipalities may levy fees and charges for services provided by the municipalities and for capital costs related to those services; and

Whereas Council of the Township of Georgian Bluffs deems it necessary and expedient to pass a by-law to establish water rates and associated interest and penalty charges for water systems owned and operated by the Township of Georgian Bluffs for the year 2022

Now Therefore, the Council of the Corporation of the Township of Georgian Bluffs enacts the following:

- 1. That the water base and consumption rates listed in Schedule 'A', attached hereto, and forming part of this by-law, are hereby established.
- 2. That the rates as defined in Schedule 'A' shall remain in force and effect until such time as a new rate is set and approved.
- 3. That By-law 2020-139 is hereby amended to remove page two of Schedule 'D'.
- 4. This By-law shall come into full force and effect upon the final passing thereof.
