1. Call to Order

Chair Ryan Thompson called the meeting to order at 5:00 PM. A quorum was present.

6. Staff Reports:

- 1) C.B.O and By-law Enforcement:
- a) August 2015 Building Report

CBO Josh Planz noted that there were 28 Building Permits issued for the month of August, 2015 compared to 52 in August, 2014. There is a construction value

of \$6,017,098.00 compared to \$2,559,900.00 for July, 2014. Permit Values for July were \$15,289.33 compared to \$25,971.47 for July, 2014.

b) By-law Enforcement Action Items Report

There are ten action items that are active at this time including an Order that was served at a residence that was not zoned for public gatherings.

The Chief Building Official discussed each item with the Committee.

He noted that there is a vacant property on Cottage Lane that has landscaping trailers stored on it and operating a business. The owner is working with the Planner in this regard.

c) Report CBO.15.05 - Bass Lake Stairs

The CBO noted that the Township owns a 20 foot wide access to the south of Bass Lake and installed a set of stairs for public access to the lake. There has been little work done to the stairs and their condition should be addressed to reduce the liability to the Township.

The CBO discussed his concerns with the Committee. The Township has no legal obligation to provide access to the water for the public. The stairs will be blocked off.

a) Memory Wall at Big Bay Cemetery

The Committee directed that the CAO and Deputy Clerk meet with Mr. Halliday regarding the memory wall and work towards an agreement.

8. New Business:

a) Centennial Park upgrades

Keith Davidson has installed a flower bed around the base of the flag pole at Centennial Park. He is requesting the donation of a load of topsoil to complete the project.

Committee directed that the Chair clarify the request regarding a load of topsoil as well as \$350.00 that is being requested by the volunteers.

b) Capital budget focus

Facilities Manager, Dan Wood, updated the Committee on his budget requirements:

- Replacing the kick plate around the arena boards at the Shallow Lake Community Centre;
- Replacing the "Big O" around the fence at the Shallow Lake Ball Diamond:
- Replacing the breakers at the bottom of the light standards at the Shallow Lake Ball Diamond;
- Upgrading the Shallow Lake Community Centre sound system which will be an estimated cost of \$3,800.00.

The Committee directed the Facilities Manager to follow up with Tom Waller regarding adding more sand to the Balmy Beach ball diamond and reshape the infield to aid in drainage. If there is not enough money in the 2015 budget, then it will be put in the 2016 budget.

The Bruce Power Workers have donated \$2500 towards the sound system at the SLCC.

The Committee noted that more money should be put into the reserve for a Zamboni.

c) Kemble Arena Committee

Chair Ryan Thompson updated Council on the Kemble Arena Committee. The Committee will not be holding a Kemble Harvest Blowout this year.

The Committee directed the Chair to email the Kemble Arena Committee to inquire if they are still a functioning committee.

d) Skate park update

The Wheel Park construction has started at the Shallow Lake Community Centre.

e) Heritage Hills Trails

Councillors Carleton and Thompson will meet with Harold Sutherland and Facilities Manager Dan Wood to discuss the trails.
