Mr. Wunderlich noted that the owners bought their property with access to the property. The value of the property has now been reduced as there is no access to the lake.

Mayor Barfoot noted that Council is open to discussion regarding the stairs. A legal opinion may be sought from the Township solicitor regarding the Township's legal obligation to keep the stairs open. Council has not made a final decision. The stairs will not be left in the condition they are today.
