# 5. Presentation by Wessuc/Fitec - Operation of BioGRID Assets

The Director of Sales, Environmental Manager of Wessuc, and the Owner of Fitec were in attendance. They presented an overview of their company and highlighted their services including:

- CCTV & Flushing
- Dewatering
- Haulage
- Lagoon cleaning
- Safety & Confined space training for staff
- Spot repair
- Vacuum services

Questions and comments of the Joint Councils included:

- What is the level of acceptance of the agricultural community in accepting lagoon material?
- Lessons learned through previous management of lagoon facilities

The Joint Councils engaged in discission with the Owner of Fitec regarding the Biodigestor operating proposal. Discussion included:

- Feedstock/feedstock mix evaluation
- Investigation into the feasibility what could be done with the site in today's market? Would the size need to be increased to be profitable? The Fitec owner noted that there would need to be a period to investigate the economic conditions to generate a proposal to operate the biodigester and

whether a long-term lease or purchase of the facility would be most feasible.

- Possibility of profit in decommissioning
- Reusable assets is there any value?
