Whereas, the Council for the Township of Georgian Bluffs deems it necessary and expedient to adopt the 2024 operating and capital budgets for the Township of Georgian Bluffs; and

Therefore, the Council of the Corporation of the Township of Georgian Bluffs enacts the following:

- 1. That the 2024 Estimated Operating and Capital Sums required for the Township of Georgian Bluffs are hereby adopted as set out in Schedule A, attached hereto and forming part of this by-law.
- 2. That this by-law shall come into force and effect upon being passed by Council.
